# FUMC ENDOWMENT FOUNDATION 2023 Annual Report


The FUMC Endowment Foundation Board of Stewards is pleased to provide to the congregation the 2023 Annual Report of the Foundation's investments value, performance, and funding for church programs.

Created in 2001, the Foundation accepts, manages, and distributes funds to promote and support existing and future programs at First Church. **The purpose of the Foundation is to enhance the mission and outreach of our church beyond the annual operating budget.** Foundation funds are entirely separate and distinct from the funds that support the day-to-day operating budget of the church.

In 2023 the Foundation was able to approve and distribute funds to the church in the amount of **\$58,620 for programs, activities, and projects**. Each fund has its own distinct policy for determining the distribution amount as a percentage of the fund's value. **Since its inception, the Foundation has distributed \$1,413,952 to the church.** 

After an initial investment of \$356,000 in 2001, through the generosity of our members and solid management by our investment committee, **the Foundation portfolio has grown to \$2,119,609 by the end of 2023**. The funds realized a **22.68% return for the year**. The Foundation continues to follow a strategy of investing in equities for long-term growth.
